





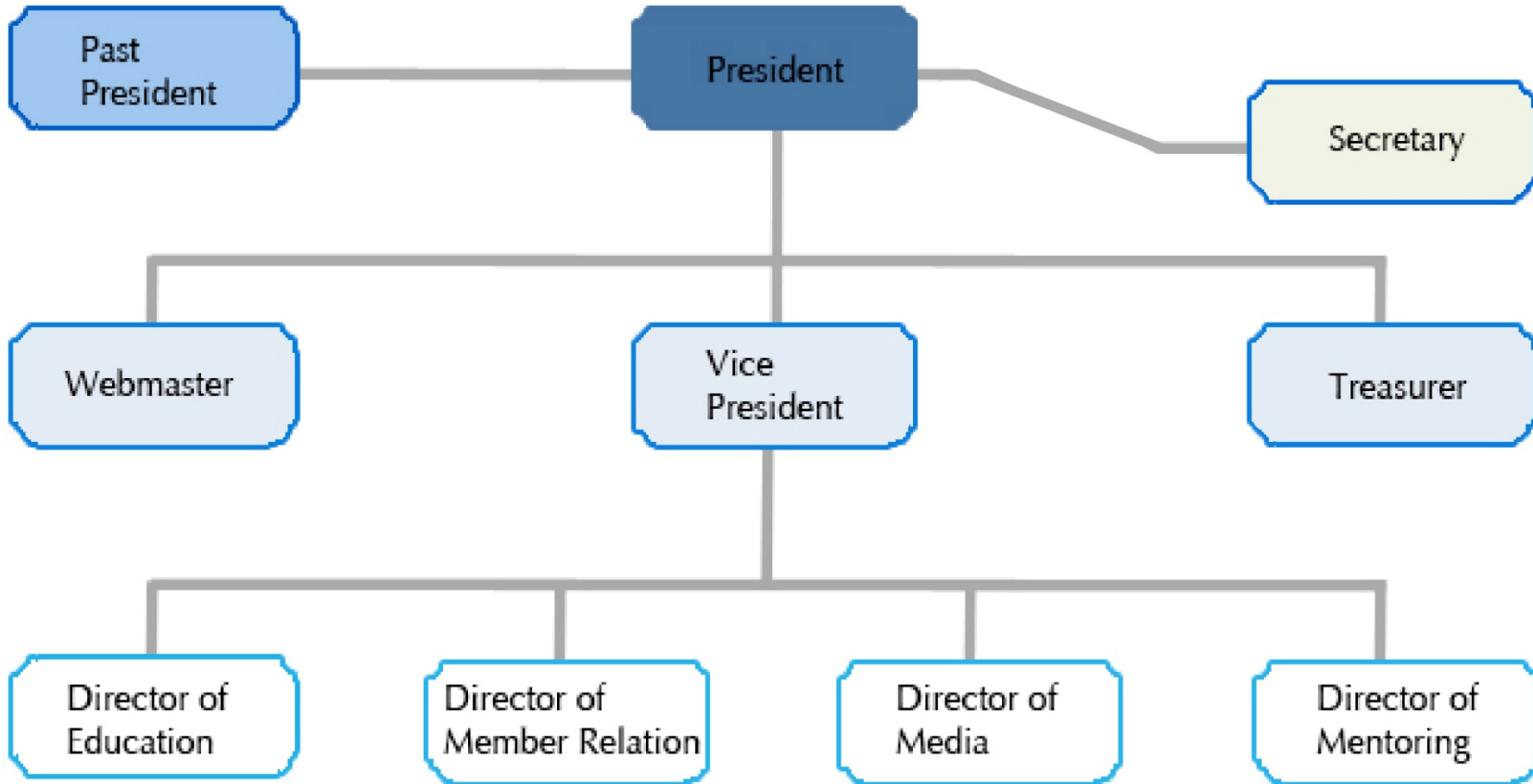



 - ✓ Location: TBD (some farm in Warwick area)



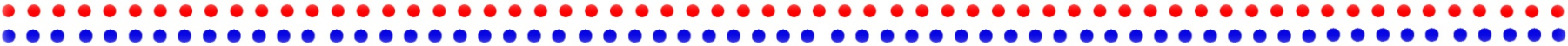
Mentorship

- Review of KAAS Mentoring Program
 - ✓ We recognized the demand of members to utilize networking opportunities to achieve professional and personal growth
 - ✓ Mentorship involves pair partnering between the more experienced (mentor) and less experienced (mentee) via mutual agreement
 - ✓ Mentors can develop and practice their leadership
 - ✓ Mentorship is not a sponsorship or a guarantee of job position
 - ✓ Director of Mentoring program will review survey results and determine appropriate pairs
 - ✓ Can change or terminate at any time by any party for any reason
 - ✓ One can be both a mentor and a mentee at the same time



Mentorship (continued)

- Review of KAAS Mentoring Program (continued)
 - ✓ Will distribute mentorship questionnaire shortly
 - ✓ Pairs will be announced in mid to late June
 - ✓ Once pairs are determined, both parties will sign Confidentiality Agreement
 - ✓ Mentor-mentee relationship lasts until the end of 2012, unless requested by any party for early termination
